Evolving LSP landscapes and the Quality dimension. DILAN - a case in point

This presentation aims to bring to the fore some of the changing landscapes in LSP communication culture(s). Concurrent realities - the growing need to do justice to the diversity of actors in society, on the one hand, and interconnectivity and the affordances of the digital environment, on the other - contribute to emerging tendencies with an influence on LSP training and research. Bridging the gap between science and society is one of these tendencies, reflecting preoccupations at European level and also among language / communication analysts and educators, collaboratively working

towards finding new solutions for developing new communication competencies to serve current and future needs. In all these endeavours, the Quality dimension *per se* remains a constant, while adjusting quality assurance systems to comply with new educational needs and realities. To illustrate how well-established quality principles and standards coexist with new/adapted mechanisms for measuring and ensuring the quality of educational processes, reference will be made to the latest developments in the international Eaqquals context (www.equals.org). And finally, on the example of *DILAN* (<https://dilan4scientists.eu>) , we will pull the strings together, integrating new directions in LSP with the ongoing preoccupation for observing Quality principles in order to ensure the Quality of educational processes and of their learning outcomes.

The Trials of a Translator

Even though mechanical translation is now very much better than it was in the early days, some nuances are still better conveyed by the traditional methods. One such nuance concerns the tone of presentation. During my long career as a translator, mostly from Greek to English in the genres of history, philosophy and theology, I have often had difficulty in persuading my authors that the tone and style suitable for a domestic readership has to be adapted for an international audience if they do not want to come across as ethnically intolerant or religiously bigoted. Another aspect concerns the contextual material that must often be added. I propose telling some personal anecdotes to illustrate this, as well as the resourcefulness that was often needed by translators before the easy access to information given by the internet.

The ENGAGE code of ethics for communication between youth leaders and young people in a multicultural context

The article explores the ENGAGE project - Empowering Next Generation Advocates for Global Education, funded by the European Commission under the Erasmus+ Programme and coordinated by the EuroEd Foundation (Iași, Romania) in collaboration with youth and non-governmental organizations from Germany, the Czech Republic, France, and Romania. The project aims to equip youth leaders with the knowledge, skills, and tools needed to navigate communication effectively across cultures and promote democratic participation and European values. The article looks at the development of the ENGAGE Code, highlighting its principles, inclusive communication practices, trust-building across cultures, while also fostering cultural sensitivity and awareness.

The finality of human life, in other words the fundamental reason justifying its existence, has been a major subject of debate throughout a large part of the history of Western philosophy. Under these circumstances, the emergence of hedonism in Ancient Greece should not come as a surprise, and yet, this radical system of thinking, which identifies man's reason for being and overall destiny with pleasure, has enjoyed a remarkable popularity since its very beginning. Unfortunately, as it has travelled through centuries, the concept's meaning has been altered by the passage of time, becoming almost a caricature, the depositary of many preconceived ideas coalescing into the negative image of a debauched behaviour. This article aims to go back to the roots of this moral philosophy and in particular to its two founders – Aristippus and Epicurus – in order to attempt a restoration of its original meaning; it will insist chiefly on the novelty of the Epicurean reasoning with regards to the ethical tradition, namely its attempt to reconcile pleasure and happiness, individual satisfaction and collective well-being within the ideal figure of the sage.

The connection between these narrative instances will come to light, as the reading progresses, highlighting a nocturnal universe that closes the cultural picture of the society described by the author in an unusual way.

Forging Personas and Interpersonal Bonds: The Mother-Daughter Trope in Greta Gerwig's Lady Bird

My paper focuses on the mother-daughter relationship in Greta Gerwig's 2017 movie, *Lady Bird*. A practice of "disidentification" occurs in the case of Christine, the protagonist, since she discards her real name in most social contexts, and manages to convince those around her to call her by her alias, the hybrid *Lady Bird*. My analysis highlights Christine's escapist tendencies, in a post-9/11 America and in the context of third-wave feminism. I will refer to scenes where the main character fluctuates between her made-up persona and the more authentic identity, in her search for independence from her mother and her roots. Such instances lead to (self-)revelations, through which Christine realizes that women can become empowered as soon as they first treasure their bonds among themselves, and learn both where they come from and where they are supposed to head to, in order for them to also leave their imprint for future generations.

Simbolismul morții în «Romancero gitano» de Federico García Lorca

El presente trabajo propone un estudio de los símbolos lorquianos referentes a la muerte, unos elementos peculiares en el *Romancero gitano*. Mediante el método comparativo, este análisis permite que el lector del volumen pueda ver con los ojos del poeta granadino como se manifiesta la muerte, en todas sus modalidades. Así, la muerte en el *Romancero gitano* es física (*Romance de la luna, luna, Martirio de Santa Olalla, Reyerta* etc.) o psicológica (*La monja gitana, Thamar y Amnón*); a veces puede ser incluso una "doble muerte" (*Romance sonámbulo*). Lorca permite a los

lectores que perciban la llegada de la muerte, creando atmósferas inquietantes mediante la presencia de estos símbolos particulares: la luna-emblema de la muerte lorquiana-, los caballos, los jinetes, los ángeles, la sangre, los metales, los arcos, los relojes, el cuchillo, etc. Dichos elementos aparecen tanto de manera directa, como indirecta, a través de metáforas y metonimias típicas de la poesía moderna.

Stuart Hall and the Making of Cultural Studies: Intellectual Biography and Theoretical Legacy

Stuart Hall remains one of the most influential figures in the field of Cultural Studies. He played a pivotal role in transforming the study of culture into a politically engaged, interdisciplinary field that interrogates power, identity, ideology, and representation within everyday life. This paper begins with a concise biographical overview, then presents his major theoretical contributions, including his rethinking of Marxism through the lens of Antonio Gramsci, his articulation of the concepts of articulation, encoding/decoding, diaspora, and hybridity, and his foundational work on race, ethnicity, and identity in postcolonial Britain. Hall's work did not merely describe cultural processes; it challenged dominant ideologies and emphasized the role of culture as a site of contestation and transformation. This study underscores how Hall's critical engagement with questions of hegemony, media, and representation remains profoundly relevant in contemporary discussions of multiculturalism, globalization, and identity politics. Through an exploration of his theoretical legacy, this paper aims at reaffirming Hall's centrality to Cultural Studies as both a methodological orientation and a political project.

Jewish American Literature: A Mirror of Migration, Identity, and Cultural Integration

Jewish American Literature reflects Jewish American experience. It illustrates the struggles of immigrant life, the stable yet alienated middle-class existence that followed, and finally the unique challenges of cultural acceptance. By the 17th century, waves of Jewish immigrants moved from Europe to America bringing with them their rich linguistic archives and Jewish culture. This paper presents an overview of Jewish American Literature (JAL) as a dynamic cultural and literary tradition that encapsulates the evolving Jewish experience. It traces the historical trajectory of Jewish immigration to America, situating the emergence of JAL within the broader socio-political context of Jewish diaspora and American assimilation. Attention is paid to the key literary forms and stylistic evolutions that characterize this tradition, from immigrant realism and Yiddish-influenced prose to postmodern irony and metafiction. Through an exploration of novels, short stories, and essays, this paper highlights the genre's thematic preoccupations with generational conflict, religious heritage, linguistic hybridity, and the pursuit of the American Dream.

Politețea în context intercultural: o comparație între români și spanioli

Articolul analizează comparativ manifestările politeții în cultura română și cea spaniolă, având ca punct de plecare teoriile consacrate ale curtoaziei (Lakoff, Leech, Brown & Levinson). Scopul este de a evidenția diferențele culturale în exprimarea respectului și în strategiile de interacțiune verbală, în contexte precum relația profesor-elev, dialogul cu vârstnicii sau comunicarea în familie. Studiul ilustrează contrastele dintre politețea normativă, specifică României, și politețea strategică, predominantă în Spania. Rezultatele oferă o înțelegere profundă a modului în care normele culturale influențează dinamica comunicării interpersonale.

Storytelling in Healthcare Settings: Teaching Types of Narratives to Medical Students

Narratives play a vital role in healthcare by fostering empathy, enhancing communication, and promoting patient-centered care. Le recours aux documents engageants, qui éveillent l'intérêt de découvrir, au-delà de la langue, des éléments culturels, s'avère être très utile. Pour ce qui est de la presse, on entre sur un domaine fascinant, qui peut dévoiler aux étudiants des aspects culturels actuels et importants de la société française. Qu'il s'agisse de la presse écrite ou de l'audio-visuel, ce domaine permet, en fonction du niveau des étudiants, des exercices très variés de compréhension et d'expression : lecture d'articles économiques et exercices d'écoute par lesquels les étudiants sont informés et découvrent l'actualité française et, dans une seconde étape, présentation d'un journal ou une revue français.
